

## **DETERMINANTS TO EMPOWERING COMMUNITY NETWORK: A CASE STUDY OF SINGLE FAMILY NETWORK**

**Abstract:** This study is a research that has been studied as a single mom in Chiang Mai. By example, five single mom persons. The purpose of this research is to study and understand the birth and the role network of single-party families occurring in Chiang Mai. It focuses on the study of the needs single mom and a reduction in gender inequality, by the outcome of the study, pointing out the experience of being branded and getting limited assistance from the government, especially the lack of responsibility father of children. The statistic of information about a single mom is often referred to as the divorce rate. Chiang Mai is an interesting area to study in this regard because the province found a marriage ratio for divorce 7years (from 2004to (2510, the top 5countries in the north. The second place in Chiang Mai, the study found some of the education in Chiang Mai province reflected in the social stigma. However, the study also focuses on a group of teenagers as the main issue. Although the young mother Group is considered one of the single mom types, the stigma of social development is considered to be consistent with conclusions of the family conference, studied at 2009/1, concluded the characteristics of a single-family in Chiang Mai that was stigma social. Chiang Mai is only one of four provinces in addition to Bangkok, Surin, and Ratchaburi with a network that is capped by the family network foundation, which can be called as the only organization that provides support directly to a single mom group. The network in Chiang Mai established the "Prichoe Group", which has been coordinating the group's development of women and other families in Chiang Mai and continues with activities. Also 2000, the researchers found that the number of organizations provides support for women and children in Chiang Mai, as well as in the year 2000, the index of households in the family head is a woman in Chiang Mai.

However, Price group after the end of the project has been budgeted by the office, Health Promotion Fund in a period of 3 years, what has been the occurrence of a single-family group in Chiang Mai where there is a gathering of activities only for the occasion, but also the efforts of the women volunteer, together with the local administrative organization to work in a single-family. ## **Literature Review**

### ***The concept of gender in Thai society***

Gender or often understood in the form framework of the female and male, which by many gender is latent to the implication of "concrete inequality" that was created by the social thinking system is a big, abstract characteristic of

sexual aberration it can be said that gender is a term interpreted through the social movement of a women's or Feminism-rights group.

The concept of women has pointed out that while “sex” is a natural state of physical health, people in all societies and cultures are shared, and we cannot make changes to these conditions, but gender is a feature that varies according to cultural context and historical conditions. That can change the properties of the gender and what the link is tied to sex, the transition is difficult due to the “power Relationship Power” that tries to make a discourse to the men's power over women at all times, that is to convey through the cultural refinement of cultures. The creation of a system thinking and belief that it is that society determines that the value of women and value of men, such as the appreciation of women in the matter chastity, which, if looking at sexual dimensions, chastity is a thin membrane on the genitals, both in women and men women are in the vagina and for men is called the second line scions at the ends of the male's penis.

However, when the virgins are viewed in gender, we will find an attempt to create a practical framework for the woman through the look of chastity that is what determines the value of women. The virgins are tied to one's husband and loyalty. If a woman who loses the chastity, it will result in a woman being completely reduced to the value, as it is seen as a bad woman to find that this renders do many women need. As Varunee Phurisinsit (2002, P.10) states that "The boundaries of men mean public life, the production of social and cultural life, while the life boundaries of women are personal and reproductive areas, and women are used as representatives of nature and individuals, which are contrary to social and cultural men," it can be seen that the women's area is blocked and interpreted. The society representing men create high expectations for women in confined spaces. It does not look to open up space for women or to open space, but only on behalf, whether it is an economic area. Politics and society in which the opening of the area is also controlled by male power. As a result, women are more and more anticipated.

So far, modern women in Thai society have a diverse social role. While still living the role in the family, and sometimes it may fall into the marital status of the first two women's status. It is caused by rubbing a press to show the role of mother and wife as social expectations. However, it is important to show the social roles in the open dimensions, such as the labor market, which sometimes women are not accepted at work. The reflection of the gender concept is the practical framework of a woman and a man that is dictated through the social system. It can be said that even if the social area is opened. - 4) The last group looks at the gender inequality tied to having political positions such as women in parliament and how many seats are there?

Therefore, the consideration of the four issues about the perspective of the measurement. It is necessary to encourage, reinforce or improve what is the cause of equitable treatment of each society as well as the four issues above. Details are as follows:

take part in social participation (economic well, the trend, the life of a good woman).

Point 2 Cultural modernity and the academic culture of the scholars on this issue emphasize the conflict of economic development by saying that economic development will be the cultural development process, where the cultural modernization of this self will enhance the concept of the liberation of women and with alternative values. This literature is particularly expected to respond to the top group in integrating women into the top group. This point will bring women's power to be born throughout society, as well as in Parliament. The essence is that this concept is looking at human development that must be linked to prosperity and social modernization. The freedom of deliverance, which can be done by changing the various barriers, and these social transitions will help to induce the power of women. This concept, even if the economic development is discussed, but it does not look at the economic changes. However, it is a cultural change that directly affects women's independence.

Point 3: The scholars in this group said that it is important to determine the gender equality is a historical heritage or a trace of what is seen in the above 2 issues. It will find that the cultural dimensions are not presented historically. In fact, what is happening today does not happen independently of history, or what was happening in the past (to date), which is likely to develop prosperity. The modernization of the society will face what is going on, whether it is an institution or cultural heritage, which will also affect the capabilities of society to improve the lives of women. This group of researchers said that the occurrence of various institutions or cultures is affected by what is happening and will still affect the future. These influences became an inert developer, which means that what happened to be politics. The cultural economy is all but independent, but it is common aftermath.

We will understand the scholars of this group to look at historical heritage that determines the current sexual equality that may result in the future of an inert trend. Strengthening the power of women in development (WOMEN'S IN DEVELOPMENT) the concept of strengthening the power has a long history in the work of social change, which consciousness-raising women and social actions (Collective) early in the development of the international era 1970s. Strengthening women's power becomes what is discussed. Together, in the era of the 1980s and 1990s, it is a root concept, also known as radical, which often takes into account the modification of a competent relationship contributing to the women's rights, and the equality between the male and rising males (Batliwala, 1993) in this work power enhancement is classified as the process of change (process of change) that has not been unraveled in consciousness (consciousness) and Collective power (mutual power/mutual power/joint power). If it is a realization (recognizing) that the power contained (appearing) produces inequality or inequality in the power that this power occurs, this may cause the rights (of some people a) increase, but at the same time it is possible to reduce the right (another person), and that power may lead to structural changes that are the foundation of equality. (Batliwala, 1993; Kabeer, 1994; Rowlands, 1997; Sen, 1997).

By the year 1994 Srilatha Batliwala has argued on the clear knowledge of "power" and "strengthening power". She supports that there must be a greater understanding of both power and power reinforcement, namely that power means control over something and the cause is also said to strengthen it. Power is the process of going to challenge the competent relationship (a process of Challenging) at that point by going to challenge an existing competent relationship and trying to control the use of power over the source of that power. Therefore, it is necessary to go back to see how the power is controlled by anyone (1994:130), which strengthened the power, it will be a matter of the process, challenge the existing power relations and control the source of energy. To mention the roots of the grass (local) that has been eliminated, participation in power reinforcement is necessary to use engagement to make the potential This is the process of change, where the heart of the transition process is to engage for Batliwala, what may be known as a spinning capability of a spiral (empowerment spiral).



“Empowering the Power, the first and important thing about power is the transformation in a competent relationship, so conducive for people who have little power to control their lives, which power has two main concepts: control over. The resources and controls manipulate the ideology (control over ideology), if the power refers to control, then the power reinforcement is the process of making those controls (gaining control). (1997:2)

From this period, it is clearer that strengthening power is not one of the best. Jo Rowlands has an example that illustrates the understanding of the power according to the concept of the women, which is highly concerned about the dynamics of oppression and oppression occurring within (dynamic of oppression and internalized oppression, 1996:87) and strengthening the power must include a process that will lead people into self-awareness that they can and have the right to occupy the area of decision or participate in the decision. The people who are empowered by the power must see that they can have the right to act and influence the decision according to Batliwala (1993) and Kabeer (1994) describe the creation of conscience (conscientization) and the process of driving local grassroots occurring in India and Bangladesh. What is happening is such a process in which to make people understand the world. Their relationship to the assumptions and beliefs on their practices and values. With the potential of the resulting change (Keyword is with potentially transformational effects), it is important to cause these things to lead to a non-modified impact and then disappear. It is a process that makes people aware of the rights and changes in the world. Thoughts and beliefs the practice viewing self-practice these changes affect.

## **Methodology**

Research in the first phase focuses on the study and understanding of the content and issues for “Qualitative Research”. The researchers focus on reaching the key informant. The manager of the family network foundation and those working to coordinate with the network of the family network foundation by acting as the leading core. It was introduced by the family network foundation, a non-governmental organization established in 1999, due to the consolidation of group parents who wanted to share the education reform and developed into a nonprofit organization that aims to achieve a steady strengthening of Thai families. The research activities of the project are divided into four main activities:

- 1) Literature review related literature consists of research reports. Publications and documents of various departments and projects. Annual Summary Report the academic papers are designed to provide a single mom. Related agencies bundles and situations in which a

single mother is faced in the context of Chiang Mai, both in the stigma. Supported by various sources, including the adjustment of life.

- 2) Contact the experts and participants experts are those who have experience straight to work with a single mom and participants. Is a single mother himself from the introduction of the master data provider.
- 3) Storage is stored in two groups by appointment in advance to make an in-depth interview that focuses on an interview telling a story or an independent experience. The talk time is about 60-90 minutes in a place where privacy and interviewees are comfortable to provide personal information. The interview is recorded to remove the tape later. The researchers will clarify the details of the study summary and consent and voluntarily make every interview.

The question used is a semi-structured questionnaire. To get the information that covers all issues from the interview. The researchers seek advice from a thorough research consultant. In the first part of the question, it relates to a common subject to familiarize themselves with the interviewee. It will then begin to ask for the experience of being a single mom, as well as the possibility to become a single mom today. Meanwhile, it is an opportunity to observe the interaction within the network group and between the network and the community.

The researchers have also applied the action research approach by getting involved in working with a single mom in a joint implementation with the foundation, particularly on the initiative of the current project, microcredit, by a single mom. In determining whether there is a need for microcredit projects, and how the operational research is a guideline that can cause changes in a particular context. When such changes can be made and practical in real situations and promote justice in society. By increasing the involvement of the fullest stakeholders and with those affected by the

research (Toivenon et al, 2015), the operational research has been supplemented with the community development approach (a community development approach), which is related to the counting process, promoting participation in communities and organizations. This method of research involves a redundant process in working with a single mom and with an organization. To develop and apply concepts and assess the process. Considering that the single mom focuses on both defining and achieving their goals. The researchers have been given the opportunity from the network's consent from the family network foundation as well as a part of participation and observation; it uses areas in the community where the network is used to process activities.

### **Results and Discussion**

The cause is a single mom originally; Thai society is a big family, society, consisting of the father-mother, as well as the relative's lives in the home or the same neighborhood, but by the time that the Thai society has been transformed into a large family, one of the most common families is usually

composed of family, single-stepdad or single mom. The reason for being a single-family is more than half of the divorce or separation of the father and mother and only one of the parents who are responsible for raising the same party.

### ***A single mom experience***

- 1) Economic issues financial issues are one of the most important issues that occur with a single mom. A single mom who agrees to interview most of them is a single mom. The intermediate status is relatively unstable and is not enough equal to the expenditure. The cost of each month that a mother is responsible for whether water, electricity, charge, monthly phone, dessert or tuition fees, etc. and at the same time, those who are a single mom must bear all costs solely.

### ***Suggestion***
